Possible the meeting will be conducted via zoom or other virtual meeting sites. A decision can be made once the Government announces its updated pandemic plan on Monday, May 4th.
- e) Baseball Diamonds Quotes were received to replace the baseball diamonds which are in great need to be replaced along with the fencing at Terry Sawchuk Diamond. The estimated costs were 250-300 thousand dollars, which is unfortunately too expensive to fix all at once. If the baseball season is cancelled there will be more time to replenish, clean up, fix and repair the grass etc of the ball diamonds. The fencing around the diamonds may be fixed in stages as well. It may also be possible to level out the grounds. Cher will look into possibly hiring someone to do "lazering/leveling" of the ground to find the low areas, etc.

a) Application for government loan (\$40,000)
