10. Unfinished Business:

- **b)** Scouts Cher shared an invitation by the Scouts to attend their 40th Annual Banquet at VGCC on Saturday, February 22. Subhdeep offered to attend and represent the Board and their celebrated partnership over the last 40 years.
- The Board had a lengthy discussion regarding the continued support and valued partnership with the Scouts organization. The Board is in consensus that the lengthy partnership is a source of pride, heritage, tradition, and overall positive sense of community spirit at VG. Growing concerns of rising costs to provide safe, clean, heated, and lighted facility space to the Scouts for free were discussed as well. Comparison to other organizations/group's rental costs at VGCC, RETSD school division group user permit costs, and facility usage costs were also considered.
